School Reopening Risk Assessment

updated for 08 September 2021

The measures we list are based on current (as at 08 September 2021) government guidance:

We have to take into account:

- The number of staff and pupils expected to have in
- Any risk assessments for individual staff who are at higher risk of contracting or becoming seriously ill from coronavirus (e.g. those who are clinically vulnerable and/or who are BAME)
- Any reasonable adjustments to enable everyone to follow the measures, including pupils with EHC plans (e.g. designing approaches to help children with challenging behaviour who may struggle to follow the rules)
- The size and layout of the school premises
- The resources in stock or can be ordered easily (e.g. PPE, soap, cleaning products)

How to approach risk estimation and management

The DfE advises that you take the following approach (in this order) to reducing risks in your school:

1. **Elimination:** if an activity isn't considered essential and has risks attached, stop it
2. **Substitution:** replace the activity with one that reduces the risk. Take care not to substitute the activity with one that'll introduce new hazards
3. **Engineering controls:** introduce measures that help control or mitigate risk
4. **Administrative controls:** identify and implement the procedures to improve safety (for example, by having markings on the floor or signage around school)
5. Having gone through this process, **use PPE where the guidance advises it is required**

Respond to risks in a way that's appropriate for your school's circumstances. For each risk, consider whether there are measures in each of the above steps that you can adopt before moving onto the next step.

RAG rate control measures

Each control measure is colour coded in the appropriate colour, to make it clear how prepared we are for each measure being in place for the autumn term.

- Red: this measure cannot be put in place in our school
- Amber: this measure isn't in place yet, but can be in place for the autumn term
- Green: this measure is already in place
- Any updates assume that these control measures are in place.

We will continue to follow these protective measures

- Make sure people who are required to self-isolate don't attend school
- Advise everyone to clean their hands thoroughly and frequently
- Make sure people practise good respiratory hygiene, and promote the 'catch it, bin it, kill it' approach
- Maintain appropriate cleaning regimes
- Keep occupied spaces well ventilated
- Promote and engage with the NHS Test and Trace process
- Manage confirmed coronavirus cases
- Contain any outbreak by following advice from our local health protection team
- Make sure individuals have the appropriate personal protective equipment (PPE), for example if they need to be in close contact with a pupil who develops symptoms or gets a positive lateral flow test at school
- Promote and engage with asymptomatic testing (see more on updated testing guidance below)

Anyone self-isolating with symptoms will be encouraged to access testing and engage with the NHS Test and Trace process.

Details below

The school will inform the persons of the protocol for contacting Test and Trace and reporting the results. This process and protocols have already been successfully used during the Summer term.

If a symptomatic person comes into school, or if a pupil has a positive test whilst at school, they will be sent home immediately or isolated until they can be picked up. The **isolation room** is located in the new **Reception building near the Main gate** – see [this guidance](#) for help with this. 999 will be called if they are seriously ill or injured or their life is at risk.

In the case of a symptomatic pupil who needs to be supervised before being picked up:

- A window will be opened in the room to allow for fresh air ventilation
- If a distance of 2m can't be maintained, supervising staff will wear a fluid-resistant surgical mask
- If contact is necessary, supervising staff will also wear disposable gloves and a disposable apron
- If there's a risk of splashing to the eyes, such as from coughing, spitting or vomiting, supervising staff will also wear eye protection

Supervising staff will wash their hands thoroughly for 20 seconds after the pupil has been picked up.

We will provide home testing kits, if available, to parents/carers collecting symptomatic children, and to staff who've developed symptoms at school, if they are unable to get a test elsewhere.

Contact with a symptomatic pupil or pupil who has a positive test at school:

In exceptional circumstances, if parents/carers cannot collect their child and they agree it's age-appropriate and safe to do so, the pupil can walk, cycle or scoot home.

If you need to make alternative arrangements to transport them home:

- The local authority may be able to source a suitable vehicle to transport the pupil
- You must inform the driver that the pupil has developed symptoms/tested positive
- Staff will be offered 2 lateral flow tests per week, for use at home
- Pupils will be offered 3 lateral flow tests, taken at school 3 to 5 days apart, as they return from 8 March (you can stagger pupils' return to accommodate this, but if you do, prioritise vulnerable children, children of critical workers and years 10 to 13) – pupils can return to school after their first negative test result

This information will also be available to all staff on the intranet **(ACTIONED by IT)**

The LFD on site testing programme is currently able to be delivered at Brune Park in the BAC and an alternative provision is also available on the Brune Park site for cross MAT staff and pupils. Rapid testing at home kits will be offered at a later stage. Both schools may potentially be involved in a saliva testing programme as an alternative home testing provision.

In exceptional circumstances, if parents/carers cannot collect their child and they agree it's age-appropriate and safe to do so, the pupil can walk, cycle or scoot home. If the pupil cannot be collected or travel home independently, we will make alternative arrangements to transport the pupil home. In this case one of the following steps will be taken:

- Use of a vehicle with a bulkhead or partition that separates the driver and passenger; or
- The driver and passenger will maintain a distance of 2m from each other(possible in the large white minibuses; or
- The driver will use PPE (the same PPE as when supervising a symptomatic pupil, as explained above) and the passenger will wear a face mask if they are able to do so.
- We will speak to the local authority about sourcing a vehicle that would provide appropriate protection for the driver, and we will inform the driver that the pupil is displaying symptoms or has tested positive.

- Pupils will be offered 2 lateral flow tests per week thereafter, to take at home
- If a pupil receives a positive lateral flow test result **at school**, they must self-isolate in line with current government guidance
- If a pupil or staff member receives a positive lateral flow test result **at home**, they must self-isolate and will also need to take a 'standard' coronavirus (PCR) test to confirm their result
- Pupils and staff must report their home test results to NHS Test and Trace. They should also share their test results with your school (both home tests and PCR tests), to help with contact tracing

A deep clean will take place in the areas that the symptomatic person or a person who has tested positive has been in, and PPE will be disposed of properly, following decontamination guidance.

Rapid testing programme:

We are participating in a Saliva testing programme by Southampton University as a control measure. This has been approved as an alternative to the LFD testing . This test only needs to be performed weekly.

We will provide staff and parents/pupils (as appropriate to the pupil's age) with a privacy notice, and parents/pupils (as appropriate to the pupil's age) with a consent form, so they can consent to testing.

As an alternative:

We will continue to offer **staff** 2 lateral flow tests per week, to take at home.

We will offer **pupils** 2 lateral flow tests on-site, taken 3 to 5 days apart, upon their return to school.

Thereafter, we will ask **pupils** to take 2 lateral flow tests per week, at home.

In all cases:

- We will carefully read the government's guidance on

On the day of a person being taken ill- The team will use the fogging machines, full PPE. This equipment is already in use and has been employed by the estates team across the MAT

administering tests and ask the individual to read the instructions in the test kit carefully / explain the instructions to them (as appropriate) to make sure everyone knows how to safely administer or self-administer tests

- If the lateral flow test is **positive**, we will follow the same steps (laid out above) as if that pupil/staff member were displaying symptoms. They will need to take a 'standard' coronavirus (PCR) test to confirm their result if the lateral flow test was done at home
- If the lateral flow test is **negative**, the pupil/staff member can continue to attend school

We won't need to see evidence of a negative test result in order to allow staff and pupils to attend school.

All staff and pupils will continue to follow the measures set out in this risk assessment, even if we're participating in rapid testing.

We will ask pupils and staff to share all test results with us, and we will keep accurate records of all results. We will

<p>only share health records with the relevant people.</p> <p>We will report test results to NHS Test and Trace wherever this is required by current government guidance.</p> <p>If the school becomes aware that a pupil or a staff member has tested positive for coronavirus either with a lateral flow test or PCR test and needs advice on next steps, the school will contact the DfE helpline on 0800 046 8687 and select option 1. (If no advice is required, the school will report the case using the DfE's '<u>online attendance form daily return</u>'). The advice service (or <u>local health protection team</u>, if the call is escalated to them), will carry out a rapid risk assessment to confirm who's been in close contact with the person when infectious.</p> <p>The school will ask (using a template letter from the local health protection team) all close contacts to self-isolate in line with current government guidance.</p> <p>If there are 2 or more confirmed cases within 14 days, or an overall rise in sickness absence where coronavirus is suspected, the school will work with the local health protection team, who can be reached by calling the DfE helpline and selecting option 1, to decide if additional action is needed.
